This Addendum to the Light-Duty Motor Vehicle Purchase or Lease Incentive Program (LDPLIP) serves to amend the Application Submission Deadline.

Per Section 3.2 of the LDPLIP Request for Grant Applications, TCEQ may award no more than 2,000 grants for hydrogen fuel cell or other electric drive (plug-in or plug-in hybrid) vehicles. The current number of applications and reservations received for hydrogen fuel cell or other electric drive (plug-in or plug-in hybrid) vehicles exceeds 2,000. TCEQ expects to award all 2,000 grants from this pool of applications/reservations.

TCEQ is therefore suspending the acceptance of applications for the purchase or lease of a new light-duty motor vehicle powered by hydrogen fuel cell or other electric drive (plug-in or plug-in hybrid) and amending the Application Submission Deadline for hydrogen fuel cell or other electric drive (plug-in or plug-in hybrid) to January 30, 2024, until 5:00 p.m., Central Time.
