Update on General Permit - Darrell Williams

Our understanding of the issues discussed at the September 27, 2004 meeting on implementation of the CAFO General Permit is listed below:

• Notice of Intent

- TCEQ will consider requests for extensions beyond the NOI application deadline of October 26, 2004 on a case-by-case basis. Requests for extensions should be made by individual CAFOs or as groups of CAFOs submitted by livestock organizations, CAFO consultants, or other CAFO representatives.
- Previously authorized CAFOs and expansions of existing CAFOs that have not yet been constructed should check the box in Section F.1. for "Existing Facility" and list the maximum number of head previously authorized by the Registration or Individual Permit as the "Number Currently Authorized" in Section F.10. On the Notice of Intent application.

• Notice of Change

- ► A Notice of Change form is currently being developed by TCEQ staff
- Until a Notice of Change form is finalized, a CAFO can submit changes to the TCEQ by letter correspondence.

Annual Report to TCEQ

- The form for the Annual Report to the TCEQ has been drafted by TCEQ staff
- The section in the draft Annual Report titled "Instances of Noncompliance not Previously Reported" was deleted
- The first Annul Report will be due February 15, after coverage under the general permit

• Revised Potential Pollution Prevention

- Potential Pollutant Sources and Spill Response: A checklist-type format for the listing of potential pollutant sources is appropriate. In addition, an emergency response plan is only needed for those substances that typically merit a hazardous materials type of response, such as fuel, oil and pesticides.
- to determine that inundation by a 100-year flood is not physically possible or protect the control facility from the 100 year flood. If the CAFO operator is unsure, a licensed professional engineer should conduct an evaluation.
- Employee Training Daily Inspection of Water Lines: A daily inspection of water lines within the drainage area of the RCS in practice can be implemented through employee training. Repairs made to broken water lines within the drainage area of the RCS should be recorded in the Weekly Reports section of the PPP. No daily log of the inspection is required by the PPP.
- Weather Conditions: Those conditions that should be recorded on the day of onsite manure or wastewater application and 24 hours before and after application included: 1) rainfall, 2) high and low temperature for each day, and 3) an indication of the cloud cover for each day. Weather conditions can be recorded manually or from a weather station (located onsite or in the vicinity of the CAFO) or from a local weather report (newspaper, TV, radio station, etc.)
- Nutrient Management Plans: A suggested template for the Nutrient Management Plan required by the CAFO General Permit will be developed as part of a

coordinated effort between TCEQ staff, CAFO organizations, and other appropriate agencies. CAFOs and Certified Nutrient Management Specialists that have developed site-specific nutrient management planning documents and other tools will not be precluded from using those formats.

Permitting Update - Beth Fraser

- 475 NOIs received 19 new facilities
- 212 NOIs acknowledged, 83 extension requests application letter drafted
- 45 renewal applications pending that have not sent NOIs
- Permits first reviewed in Permit Administrative Review
- Then goes to CAFO team for technical review
- 150-180 days for new permit processing does not include public meeting
- Individual Permit
 - ► 53 applications received 16 sent to administrative review, 37 in technical review
 - Still need information for quite a few
 - ► NOD letters were sent
 - ► There are 3 individual permits that do not expire until 2005 and 2007
 - Working on language for final permit with EPA
 - ► EPA asking for more clarification
